JOSHUA AIKEN DECISION 16 March 2018

Mr NICK MURRAY appeared on behalf of the HRV Stewards

We have decided in this matter to dismiss the appeal as to the decision. We note that the rule in this matter is "a person shall not drive in a manner which in the opinion of the stewards is unacceptable". In this case, the submissions and the evidence that Mr Aiken has presented has not convinced us to overturn the professional assessment of the stewards.

Essentially, we agree with the matters that have been raised by the stewards in terms of the matters taken into account on penalty - that the offence is in the mid-range and taking into account Mr Aiken's record and frequency of drives - but we think in these circumstances the appropriate suspension is a four week suspension. We've taken into account the minimum penalty guidelines as well.

In deciding on an appropriate penalty in this matter, we've taken into account all the submissions that have been made. We note that this rule is one that goes to the integrity of harness racing, particularly in respect to betting, and that there is a need for specific and general deterrence, but having said all of that, we do think that the offence is this case was probably at the lower end of the scale. We've noted that the horse 'Franks Very Much' had already shifted slightly which contributed to the gap that Mr Aiken's drive was able to get through. We also note Ms Frennings's early guilty plea, her admission that she shifted ground and her good record over a relatively short period of time but clearly she does have a very good record and we think in all of those circumstances, a fine rather than a suspension is appropriate and we've decided that the amount of that fine should be \$500.
