Introduction

The principle objective of this tender is to establish the most suitable provider of Equine Genetic Marker Testing Services for *Harness Racing Australia* (HRA).

Written Tender Response

Each Tenderer is required to provide a written submission to comprehensively address the requirements of the Conforming Tender Specification outlined in this tender document.

Oral Presentation

If an oral presentation is requested by *Harness Racing Australia*, the personnel who will be responsible for delivery of the tenderer's services to *Harness Racing Australia* (i.e. Account Chairperson and Account Executive) will be expected to actively participate in the oral presentation.

Presentations may be made in person, by Tele or Video Conference with all expenses borne by the tenderer.

Scope

Each tenderer is required to provide a written submission which concisely addresses the following key topics:-

- Credentials and Capabilities
- Service Delivery and Management
- Remuneration and Disclosure
- Transitional Arrangements

Genetic Marker Testing Program

Harness Racing Australia employs a strong commitment and regulatory framework to protect the integrity of breeding activities within the harness racing industry.

An important component of these regulations is the parentage verification of each foal prior to registration for competition or breeding activities since 2002. Parentage is verified via hair testing, with the hairs pulled from the foal's mane during the freezebranding (visual identification) procedure – usually between 3-months and 6-months of age.

The parentage verification results provide *Harness Racing Australia* with confirmation of Sire and Dam details.

In the instance of an older horse, either born prior to 2002 or imported to Australia for breeding purposes, hair is pulled from the horse's mane for the purposes of recording markers for future breeding reference.

Harness Racing Australia is also interested in looking at other innovative genetic marker programs that can add value to the harness industry. This may be in the form of, but not limited to, horse performance or health studies.
