Race 1: MORE 'F' IN FUN HANDICAP (2503 SS)

IAM CLIVE – (Kim Prentice) was unable to obtain clear running until approaching the 50m.
SHELLSTAR – (David Gravalin) which began badly was excluded from the Standing start draw.
ATOMIC SEELSTER – (Mark Reed) galloped briefly at the start.
AFTER THE RAIN – (Nicolaas Van Der Snoek) had difficulty obtaining clear running over the concluding stages.
RICKY RAINBOW – (Ryan Warwick) galloped briefly at the start then raced roughly racing towards the front straight to receive the bell. After commencing a late three wide run, gave ground over the concluding stages.
ALKITTO – (Aaron Skalecki) driver was reprimanded under Rule 156(2)(c) for the manner in which he used his whip over the concluding stages.
CRANKY JACK – (Callan Suvaljko) which galloped briefly then broke shortly after the start will not be permitted to race in Standing Starts until such time as it has completed two satisfactory Standing Start trials. Unable to obtain clear running over the concluding stages.

Race 2: ALLTOOLS STAKES (2548 MBL)

PYRGOS – (Vance Stampalia) after being obliged to race wider on the track racing in the front straight to receive the bell, gave ground over the concluding stages.
FRANCO STRIKER – (Ryan Warwick) the removable deafeners failed to release.

Race 3: BE ACTIVE STAKES (2143 MBL)

BUCK THE ODDS – (Aaron Skalecki) touched the barrier just prior to release and as a result shifted up the track slightly.

Race 4: BREAR & DOONAN STAKES (1742 MBL)

Nothing to report.

Race 5: TOYOTA FINANCIAL SERVICES STAKES (1742 MBL)

Stewards delayed the All Clear after driver Callan Suvaljko (TRIAL BY JURY) requested to view the film of an incident near the 1200m where he felt he may have been obliged to race wider on the track by the outward movement of WALTON FLYER. After viewing the film on a number of occasions, driver Suvaljko elected not to proceed with the matter.
RIDE SALLY RIDE – (James Schrader) underwent a veterinary examination on arrival on course after Trainer Jarrad Humphries reported that the mare had been extremely fractious on route to the course. A further examination was carried out after RIDE SALLY RIDE completed its preliminary and the mare was passed fit to start, held up for clear running until passing the 100m.
JUSTLIKEJOSH – (Craig Goldfinch) raced roughly racing towards the back straight on the final occasion.
MISTER BOCELLI – (Chris Lewis) raced three wide throughout.
VIA LAS VEGAS – (Vance Stampalia) shifted out under pressure in the run to the finish.
VOICE OF FREEDOM – (Colin Brown) gave ground over the concluding stages.
CASHMORE VANCE – (Kim Young) was held up until gaining an inside run over the final stages.

Race 6: 2006 2YO COLTS & GELDINGS WESTERN CROWN CLASSIC FINAL (1742 MBL)

ONE FORTYNINE – (Jeffrey Wegner) which broke racing towards the back straight on the first occasion will not be permitted to race for fourteen days and until such time as it completes two satisfactory trials.
BANKERS CHOICE – (Mark Reed) was checked racing towards the back straight on the first occasion and completed the event with the offside knee boot down.

Race 7: 2006 2YO FILLIES WESTERN CROWN CLASSIC FINAL (1742 MBL)

MY SPECIALTY – (Mark Reed) which broke racing in the back straight on the final occasion will not be permitted to race for six days and until such time as it completes a satisfactory trial.
HOMELAND SCORE – (Clinton Kimes) which broke in the back straight on the first occasion before being retired from the event, will not be permitted to race for six days and until such time as it completes a satisfactory trial.
VANCELOT LADY – (Colin Brown) underwent a veterinary examination on arrival on course after Trainer Andrew De Campo reported that the filly had suffered a puncture wound to the near fore foot during the week. The filly was passed fit to start.
FOXY DIVA (Aldo Cortopassi) was checked racing in the back straight on the final occasion.
ADDA COOL MIL – (Susan Roberts) was checked racing in the back straight on the final occasion.

Race 8: SWAN BREWERY CONDITIONED HANDICAP (2102 SS)

ARABARAMA – (David Gravalin) galloped briefly at the start.
LEVITYS RAINBOW – (Garry Butler) galloped out.
BLACKANSWEET – (Joe Suvaljko) which began badly will remain excluded from the Standing Start draw.
TO THE MOUNTAIN – (Gary Hall Jnr) forced wide in the front straight to receive the bell and then commenced to hang inwards. Had the near side sulky wheel flattened and raced roughly shortly after before being retired from the event. A post race veterinary examination revealed the gelding to be sore in the off fore foot. Trainer Mr R Olivieri was advised that the gelding would not be permitted to race or trial until a Veterinary Certificate of Soundness was produced.
CRYSTAL JOURNEY – (Kim Young) which began badly was excluded from the Standing Start draw.
MONEY MASTER – (Chris Lewis) had difficulty obtaining clear running to the finish.
ALBERT RAINER – (Callan Suvaljko) was inconvenienced at the start.
MISSISSIPPI DELTA – (Wesley Andrews) had difficulty obtaining clear running to the finish.

Race 9: TOYOTA COROLLA HANDICAP (2503 SS)

FOYS SURPRISE – (Gary Hall Jnr) was held up until obtaining an inside run over the concluding stages.
ROCKY ROBINSON – (Kim Prentice) shifted out under pressure in the run to the finish.
GOOD HEAVENS HOLMES – (Mark Reed) raced roughly shortly after the start.
BRYCE CANYON – (Mike Reed) was checked at the start.
VIKING RULER – (Darren Kerr) was severely checked at the start.
JAKE THE MUS – (Colin Brown) which jumped sideways at the start then began badly was placed on its last chance in Standing Start events.
THE OLD CAMP – (Ryan Warwick) had a tendency to hang outwards at various stages and then was held up. Checked near the 50m when attempting to make ground in restricted room.

Race 10: LINDEMANS STAKES (2548 MBL)

IRON CLAD LOMBO – (Morgan Woodley) raced roughly racing into the back straight on the first occasion then had a tendency to hang outwards at various stages. Broke when being urged racing in the front straight on the final occasion. Will not be permitted to race for six days and until such time as it completes a satisfactory trial. A post race veterinary examination revealed nothing amiss.
ON THE SIDE – (Ryan Warwick) when questioned on his reasons for commencing a three wide run with cover with two laps to travel, driver explained that he had elected to follow MAGNEATO at that stage of the race as in his opinion that gelding would be unable to gain the lead of the one wide line and thus carry him into the race for a considerable distance. He was confident that given the racing characteristics of other runners there was little likelihood of him being obliged to race wider on the track.
MAGNEATO – (Colin Brown) after commencing a three wide run racing into the front straight with two laps to travel, gave ground over the concluding stages. When questioned on his driving tactics driver explained that at that stage of the race as the pace eased he elected to commence a forward move as the trainer had advised him that the gelding was best suited being driven as a strong stayer. His intention at that stage was to go forward to race at the lead of the one wide line, however shortly after commencing a three wide move MAGNEATO lost momentum obliging him to drive vigorously with the whip in an effort to get the gelding to

respond. Racing out of the front straight as he was electing to desist with the forward move the gelding commenced to make ground and he therefore elected to persist with his original plan to attempt to gain the lead of the one wide line.
