#### **RACE 1: TOOHEYS NEW 2YO STAKES (2130 MBL)**

ARGENT TREASURE – (Chris Lewis) broke racing towards the front straight on the first occasion. It was subsequently established that both the halter shortening adjusters had broken. The gear was inspected and found to be of good quality. In the circumstances, no action was taken.

DEVILS PLAYMATE – (Colin Brown) performed poorly to finish a considerable distance from the remainder of the field. Placed on its last chance to race competitively.

NOWUSEE ME – (Andrew De Campo) driver fined \$100 under Rule 162(1)(h) out of position at release, failed to obtain a clear run to the finish.

QUITE LOADED – (Callan Suvaljko) checked racing towards the front straight on the first occasion.

#### **RACE 2: SWAN DRAUGHT WA OAKS PRELUDE 1 (2536 MBL)**

TIFFANY CASE – (Clinton Hall) gave ground over the concluding stages.

MAC A LOT – (Brad Stampalia) hung outwards at various stages whilst leading, shifted out under pressure in the run to the finish.

AMARANTINE – (Mark Reed) gave ground over the concluding stages.

MISS SHANLEY – (Justin Prentice) failed to run on over the concluding stages. A post race veterinary examination revealed the filly to have a minor abrasion to the near hind bumper. The trainer had been disappointed in the performance and it was his intention to monitor the filly's condition over the weekend and report any findings to the Stewards.

CHARLOTTE CHURCH – (Grant Williams) when questioned on the performance trainer/driver expressed disappointment and was of the opinion that the filly, through inexperience, had been unsuited by the circumstances of the race.

#### **RACE 3: HAHN PREMIUM LIGHT STAKES (1730 MBL)**

SIGNLINE – (Ryan Bell) failed to run on over the concluding stages.

TROUBLESCENE – (Stephen Reed) held up until obtaining a late run.

#### **General**

Following the running of this race Stewards amended the weather to showery.

#### **RACE 4: HAHN SUPER DRY STAKES (2536 MBL)**

CHAZSALICO – (Terry Purnell) had difficulty obtaining a clear run to the finish.

ITS NO FAKE – (Colin Brown) had a tendency to over race at various stages.

#### **RACE 5: 2007 TOOHEYS EXTRA DRY 4YO MARES SIRES FINAL (2130 MBL)**

JANNALI JAYLO – (Dennis Wych) gave ground over the concluding stages.

MON POPPY MIA – (Mark Reed) hung inwards racing into the front straight on the final occasion making contact with several marker pegs.

**General**

Trainer Les Coulson was reprimanded for presenting THE POWER WITHIN late in the parade ring prior to the running of this event.

**RACE 6: 2007 BECKS 4YO HORSES & GELDINGS SIRES FINAL (2130 MBL)**

MIKE WAZOWSKI – (Grant Williams) when placed in restricted room racing towards the front straight on the final occasion made contact with several marker pegs.

**RACE 7: 2007 XXXX GOLD AUTUMN CHAMPIONSHIP STAKES (2130 MBL)**

Nothing to report.

**RACE 8: HEINEKEN CONDITIONED HANDICAP (2102 SS)**

RICKY RAINBOW – (Donald Harper) raced roughly shortly after the start, then broke gait for a short distance, placed on its last chance in the Standing Start draw.

JILLIBY CRUISING – (Jamie Rigoli) tightened racing out of the back straight on the first occasion. Raced three wide throughout before failing to run on over the concluding stages.

ARTFUL MOOVER – (Justin Prentice) galloped out.

TRINITY LANE – (Mark Reed) tightened racing out the back straight on the first occasion making contact with several marker pegs.

BODY ARMOUR – (Ryan Warwick) tightened racing out of the back straight on the first occasion.

**RACE 9: EMU EXPORT CLAIMING STAKES (2130 MBL)**

DOCTEL RAGER – (Mark Reed) completed the event with the wither hopple carrying strap detached.

THE DIE IS CAST – (Vance Stampalia) shifted out under pressure in the run to the finish.

**General**

EASTWOOD STAR was claimed from this event.

**RACE 10: EMU BITTER HANDICAP (2503 SS)**

ROMAN TRICKSTER – (Aiden Warwick) began badly, excluded from the Standing Start draw.

BIG DOUG – (Clinton Hall) galloped out.

HYPOTHERMIA – (Mark Reed) began badly, excluded from the Standing Start draw.

IL POSTINO – (Andrew De Campo) unable to obtain a clear run to the finish.

ELITE ARMBRO – (Justin Prentice) failed to run on over the concluding stages.

PRECIOUS MAIDEN – (Ryan Warwick) galloped out.

HOLLYWOOD STRIDE – (Callan Suvaljko) began badly, excluded from the Standing Start draw.
