Race 1: HAHN PREMIUM LIGHT STAKES (1742 MBL)

JESMOND ROAD – (Colin Brown) was unable to obtain clear running over the concluding stages.
MEGAINTEREST – (Ray Retzlaff) after electing to make ground along the marker pegs from the 400m was unable to clear running over the concluding stages.

Race 2: TOOHEYS NEW STAKES (1742 MBL)

CASEYS BEST – (Morgan Woodley) after gaining the lead of the one wide line in the middle stages, gave ground over the concluding stages.
ATOMIC SEELSTER – (Mark Reed) raced three wide throughout.

Race 3: SWAN DRAUGHT HANDICAP (2503 SS)

CLINTONS CIGAR – (Kim Prentice) which began badly was excluded from the Standing Start draw.
WESTICE – (Mark Reed) after galloping out, was severely checked shortly after the start.
JUST JASPER – (Chris Lewis) which jumped sideways at the start beginning badly was excluded from the Standing Start draw.
SWAPS – (Vance Stampalia) over raced in the middle stages whilst racing at the lead of the one wide line.
THE OLD CAMP – (Wes Andrews) was severely checked shortly after the start.
MAGICAL MAC – (Colin Brown) was severely checked shortly after the start.
WALLY WIZARD – (Brad Stampalia) was severely checked shortly after the start. Broke racing into the front straight on the final occasion. Will not be permitted to race for six days and until such time as it completes a satisfactory trial.

Race 4: TOOHEYS EXTRA DRY STAKES (2548 MBL)

MORGANATOR – (Morgan Woodley) had a tendency to over race when racing behind the leader in the early and middle stages.
AM I TOUGH – (Ryan Bell) which hung outwards and broke for a few strides racing out of the back straight on the final occasion, will not be permitted to race for six days and until such time as it completes a satisfactory trial. Shifted out under pressure in the run to the finish.
KENDALL CASTLE – (Aaron Skalecki) broke under vigorous driving in the run to the finish. Driver was fined \$200 for Careless Driving [Rule 168(1)].
AUSSIE ATTACK – (Colin Reeves) was momentarily inconvenienced racing out of the back straight on the final occasion.
CRANKY JACK – (Callan Suvaljko) when questioned on the un-placed performance driver explained that he had been disappointed with the performance and could offer no explanation other than to suggest that the gelding may be in the early stages of a viral infection. A post race veterinary examination revealed a slight nasal discharge. Trainer advised that he would monitor the gelding's condition and advise Stewards of any development.
PERFECT ORDER – (Colin Brown) had difficulty obtaining clear running to the finish.
CALLING ELVIS – (Mark Reed) had difficulty obtaining clear running to the finish.

Race 5: BECKS HANDICAP (2907 SS)

IAM CLIVE – (Kim Prentice) shifted out under pressure in the run to the finish.
JACK FORCE – (Clinton Hall) galloped out, obtained an inside run over the concluding stages.
CHILLI DAWN – (Gary Hall Jnr) galloped out.
ARMBRO BRAVE – (Jason Woodworth) began badly.
JUSTALITTLEFELLA – (Colin Brown) galloped briefly at the start, locked sulky bridges and broke racing out of the back straight to receive the bell.
CASHMORE VANCE – (Chris Lewis) hung inwards and locked sulky bridges racing out of the back straight to receive the bell.
COOGEE BELLE – (Kate Kersley) galloped out then had difficulty obtaining clear running to the finish.

Race 6: EMU BITTER MARES STAKES (2143 MBL)

THE REAL DEAL – (Mark Reed) had difficulty obtaining clear running to the finish.
CRYSTAL JOURNEY – (Chris Lewis) broke in the middle stages of the score up, however regained its position prior to release.
THE CHAFF BANDIT – (Callan Suvaljko) gave ground over the concluding stages.

Race 7: 2006 XXXX GOLD AUTUMN CHAMPIONSHIP FINAL (2143 MBL)

OSCAR LOMBO – (Colin March) which began badly was excluded from the mobile barrier draw.
THE FINAL WORD – (Callan Suvaljko) after racing at the lead of the one wide line, gave ground over the concluding stages.
LEVITYS RAINBOW – (Clinton Hall) raced three wide for the majority of the event before being restrained to the rear.
MANSON – (Colin Reeves) which raced three wide throughout, gave ground over the concluding stages.
GEIGER COUNTER – (Bruce Hawkins) was slightly out of position at release point. Driver was reprimanded under Rule 162(1)(j) for failing to maintain his position. Gave ground over the concluding stages.
VINNIES SISTER – (Wes Andrews) which pulled up sore in the near fore tendon will not be permitted to race or trial until a veterinary Certificate of Soundness is produced.
DOCTOR EVIL – (Chris Lewis) was checked shortly after the start.

Race 8: ZATHURA STAKES (2143 MBL)

LITE RED – (Morgan Woodley) raced roughly shortly after the start.
STANLEY MOORE – (Vance Stampalia) had a tendency to over race whilst leading.

Race 9: HEINEKEN STAKES (2143 MBL)

ALABAMA JOE – (Chris Lewis) which broke in the score up and was out of position at release, was excluded from the mobile barrier draw.
KINDA BAD – (Shane Young) was momentarily tightened racing into the front straight on the final occasion.

Race 10: EMU EXPORT STAKES (2143 MBL)

Nothing to report.
