Race 1: THE WEST AUSTRALIAN NIGHTS OF THUNDER QUALIFYING HEAT 7 (1730 MBL)

HIGH AND MIGHTY – (Gary Hall Jnr) was unable to obtain a clear run over the concluding stages.
SOSA – (Matthew Scott) was momentarily tightened racing out of the back straight on the final occasion when giving ground.

RUNAM ALONG – (Morgan Woodley) hung inwards racing out of the front straight on the first occasion. Driver was advised to make a greater effort to straighten his drive in similar circumstances.

MIGHTY RIVER – (Justin Warwick) hung inwards racing out of the back straight on the final occasion, momentarily tightening another runner. Driver was reminded of his obligations.

Race 2: THE WEST AUSTRALIAN NIGHTS OF THUNDER QUALIFYING HEAT 8 (1730 MBL)

HER MAN MURRAY – (Kim Prentice) was unable to obtain a clear run until inside the final 100m.

ANOTHER NOTCH UP – (Aldo Cortopassi) failed to run on after making a three wide move from the 1200m.

Race 3: THE WEST AUSTRALIAN NIGHTS OF THUNDER QUALIFYING HEAT 9 (1730 MBL)

SCRAM JET – (Kim Young) shifted out under pressure in the run to the finish.

COLONIAL BLAZE – (Mark Reed) was held up in the early stages of the straight before gaining an inside run.

HONAN – (Matthew Scott) was unable to obtain a clear run to the finish.

ATOMIC SEELSTER – (Morgan Woodley) which began badly, was excluded from the Mobile Barrier draw.

VIA LAS VEGAS – (Vance Stampalia) failed to run on over the concluding stages.

Race 4: TOYOTA GENUINE PARTS, SERVICE & ACCESSORIES CLAIMING STAKES (1730 MBL)

JACCKA FROST – (Chris Lewis) was momentarily tightened racing into the front straight on the final occasion and then was unable to obtain a clear run to the finish.

MAGIC LOCH – (Shane Young) was unable to obtain a clear run to the finish.

DOCTEL RAGER – (Shannon Suvaljko) was held up until obtaining an inside run inside the final 100m.

Race 5: GANNON'S MARES STAKES (1730 MBL)

SMOOTH VIEW – (Craig Saligari) was unable to obtain a clear run to the finish.

WARBLING MAGGIE – (Warren Robinson) was unable to obtain a clear run to the finish.

FALCONOVA – (Mark Reed) after being obliged to race four wide racing in the front straight to receive the bell, failed to run on over the concluding stages.

BONSHAR – (James Schrader) had difficulty obtaining a clear run to the finish.

LADYLUCK – (Kate Kersley) was slightly out of position at release point. The driver was reprimanded under the provisions of Rule 162(1)(h) and advised to make a greater effort to fill her barrier position.

Race 6: VEOLIA ENVIRONMENTAL SERVICES CONDITIONED HANDICAP (2503 SS)

ROCKY ROBINSON – (Kim Young) galloped briefly at the start.

LEFT PRIDE – (Mark Reed) which began badly, was placed on its last chance in the Standing Start draw.

TAIHAPE TICKLER – (Callan Suvaljko) which began badly, was placed on its last chance in the Standing Start draw.

Race 7: 2007 JAMES BRENNAN MEMORIAL CUP (2536 MBL)

GEE WHIZ FIZZ – (Ryan Warwick) was held up until entering the home straight.

Race 8: BE ACTIVE HANDICAP (2503 SS)

MYSTYS GIRL – (Mark Reed) galloped out.

RENOUNCE – (Nigel Johns) galloped out.

MOTORING SAM – (Chris Lewis) galloped out.

MACROSSAN – (Colin Brown) galloped out.

COBARGO WIND – (Morgan Woodley) jumped sideways at the start.

NEXT TIGER – (Michael Tenardi) galloped briefly at the start and was inconvenienced shortly afterwards.

VINTAGE CONCERTO – (Gary Hall Jnr) shifted out under pressure in the run to the finish.

FLOYD BROMAC – (Andrew De Campo) which galloped out, will remain excluded from the Standing Start draw.

Race 9: XXXX GOLD HANDICAP (2503 SS)

General

The start of this race was delayed approximately four minutes when MOTORING ALDEBARAN (Kim Prentice) sprung the near fore plate during its preliminary. The gelding raced bare in front.

OXFORD DEBATE – (Justin Prentice) broke shortly after the start and galloped for a considerable distance. It was subsequently established that the near side hopple-shortening pin had released prematurely, becoming entangled in the hopple-connecting strap. Under the circumstances no action was taken.

J DS BEAU – (Morgan Woodley) galloped out. Driver was reprimanded under the provisions of Rule 156(2)(f) for the manner in which he used the whip after the gelding's run had finished.

GHOST DANCE – (Callan Suvaljko) galloped out and failed to run on over the concluding stages.

MOTORING ALDEBARAN – (Kim Prentice) began badly and will remain excluded from the Standing Start draw.

THE LAST PADRON – (Hayden Charles) which began badly, losing considerable ground and trailing the field thereafter, was placed on its last chance in the draw.

PERFECT ORDER – (Colin Brown) was checked at the start.

Race 10: CHANNEL NINE STAKES (2130 MBL)

REPARATION – (Clinton Hall) which raced roughly after the start, was placed on its last chance in the draw.

BIRDCAGE – (Mark Reed) was unable to obtain a clear run to the finish.

BRONSKI BOMBER – (Shane Young) was held up in the early stages of the straight before gaining a late inside run.

BAYETE NKOSI – (Andrew De Campo) locked wheels racing out of the back straight on the first occasion.

WILD AND FREE – (Craig Murphy) was unable to obtain a clear run to the finish.

ULRICH – (Gary Hall Jnr) shifted out under pressure in the run to the finish.

JOHNNY VETERAN – (Shannon Suvaljko) was severely checked shortly after the start.

SCREWDRIVER – (Callan Suvaljko) locked wheels racing out of the back straight on the first occasion.
