### **Stipendiary Stewards Report**

#### **Race 1: CLAISEBROOK COVE STAKES (1730 MBL)**

MEGAINTEREST – (Ray Retzlaff) hung out in the score up then commenced slowly, a warning was issued.  
MANSON – (Nigel Johns) was checked racing in the back straight and towards the front straight on the final occasion behind a tiring runner.  
JUSTABITJOLLY – (Stephen Reed) performed poorly to give ground over the final 600m. Trainer Maryann White was advised that the gelding would not be permitted to race in the metropolitan area until regaining country form.  
SMART JAG – (Callan Suvaljko) shifted out under pressure in the run to the finish.  
COVENT GARDEN – (Darren Kerr) was out of position at release point. Driver reprimanded under the provisions of Rule 162(1)(h) for failing to come into position.

#### **Race 2: BE ACTIVE STAKES (1730 MBL)**

LACHIE BRAVO – (Colin Olsen) failed to run on over the concluding stages.  
IMAGREEKTOO – (Michael Tenardi) failed to run on over the concluding stages.  
WEONA SHOWDOWN – (Craig Saligari) failed to run on over the concluding stages.  
J DS BEAU – (Aiden Warwick) failed to run on over the concluding stages.

#### **Race 3: REGAL PLACE CLAIMING STAKES (2130 MBL)**

DUFFLECOAT FLYER – (Stephen Reed) shifted out under pressure in the run to the finish.  
NEXT TIGER – (Michael Tenardi) which raced three wide throughout, failed to run on over the concluding stages.  
PAYNIN – (Kade Howson) had difficulty obtaining a clear run to the finish.

#### **Race 4: RICK TUCKER WELDING PATHWAY SERIES STAKES (1730 MBL)**

MATTER OF MONEY – (Ryan Warwick) failed to run on over the concluding stages. The gelding was placed on its last chance to race competitively.  
BALI GIRL – (Stephen Reed) the offside sulky tyre deflated shortly after the start with the mare failing to run on over the concluding stages in consequence.  
JIMMY KELLY – (Callan Suvaljko) failed to run on over the concluding stages.

#### **Race 5: MARDALUP PARK STAKES (2130 MBL)**

BLACK LINE – (Gary Hall Jnr) shifted out under pressure in the run to the finish.  
ALBERT CHIEF – (Clinton Hall) the near side sulky wheel was contacted and flattened by another runner racing into the home straight on the final occasion.  
WAKE NED DEVINE – (Glen Walton) was held up until obtaining an inside run in the front straight to the finish.  
WAY OF LIFE – (Justin Prentice) had a tendency to hang inwards racing towards the front straight on the final occasion making it difficult for the driver to ease the gelding wider on the track. In consequence it contacted a sulky and raced roughly.

MOTOR HOLMES – (Aaron Skalecki) was held up until obtaining an inside run in the front straight in the run to the finish.

**Race 6: 2007 MARES MILE (1730 MBL)**

JUPITERS DARLING – (Gary Hall Jnr) was inconvenienced when momentarily placed in restricted room racing out of the back straight on the final occasion.

CEE GEORGINA – (Ryan Bell) failed to run on over the concluding stages.

DILINGERS REIGN – (Kim Prentice) hung inwards shortly after the start.

RED HOT DATE – (Justin Warwick) was held until entering the home straight.

**Race 7: 2007 CITY OF PERTH CUP (1730 MBL)**

LIGHTNING JAKE – (Chris Lewis) was obliged to race four wide on the track for a short distance racing towards the front straight to receive the bell.

**General**

Stewards inquired into reason for LIGHTNING JAKE (Chris Lewis) being obliged to race wider on the track racing towards the front straight to receive the bell. It was established that LUCKY PUNCH (Kade Howson) moved from the one wide line to the three wide line to the inside of LIGHTNING JAKE prior to the ease out pole. Kade Howson (LUCKY PUNCH) pleaded guilty to a charge of making another runner cover more ground than necessary issued under the provisions of Rule 163(1)(b). His reinsperson's licence was suspended for a period of twenty one days.

**Race 8: GHOST RIDER CONDITIONED HANDICAP (2503 SS)**

SHELLSTAR – (Stephen Reed) raced roughly after the start.

OUR SAFELY STAR – (Colin Brown) galloped out.

JUST JASPER – (Aldo Cortopassi) which began badly shifting up the track was excluded from the Standing Start draw.

MORGANATOR – (Ryan Warwick) was severely checked shortly after the start and failed to run on over the concluding stages.

MISTER TUBERTS – (Gary Hall Jnr) which began badly, was placed on its last chance in the draw. Checked shortly after the start.

OXFORD DEBATE – (Callan Suvaljko) which began badly, was excluded from the Standing Start draw.

LEACRAIG – (Michael Sangalli) was held up until obtaining a clear run inside the 100m.

HILTON ADONIS – (Justin Warwick) commenced slowly.

**Race 9: VICTORIA GARDENS HANDICAP (2503 SS)**

YEEHAH COWBOY – (Gary Hall Jnr) was severely checked racing out of the back straight on the final occasion.

BRILLIANT VIEW – (Craig Saligari) the near side sulky tyre deflated at approximately the 1200m mark.

MEMO – (Aiden Warwick) broke racing out of the front straight on the first occasion when the offside hopple shortening pin released prematurely. Under the circumstances, no action was taken.

MR ACEMAN – (Stephen Reed) was checked racing out of the back straight on the final occasion.

WIZARD OF SCAR – (Ian Davie) racing out of the back straight on the final occasion hung inwards despite the efforts of its driver making contact with a sulky and breaking gait dislodging its driver. WIZARD OF SCAR will not be permitted to race for six days and until such time as it completes a satisfactory trial.

STONE HEART – (Dan Miller) which galloped out, will remain excluded from the Standing Start draw. Severely checked with the driver being dislodged racing out of the back straight on the final occasion.

KENDALL CASTLE – (Nigel Johns) which stood flat-footed at the start and then broke shortly afterwards, will remain excluded from the Standing Start draw.

**Race 10: SCHWEPPE'S STAKES (2536 MBL)**

VILLAGE JIM – (Grant Williams) over raced in the middle stages, inconvenienced racing in the front straight on the final occasion.

CUMBRIA WARRIOR – (Clinton Hall) shifted out under pressure in the run to the finish.

MIDNIGHT CHILL – (Susan Roberts) severely checked racing towards the front straight on the final occasion. Returned having cast the off fore plate.

SAFE DECISION – (Aldo Cortopassi) was held up until obtaining an inside run shortly after straightening.

**General**

Stewards inquired into the reason for MIDNIGHT CHILL (Susan Roberts) being severely checked racing towards the front straight on the final occasion. Grant Williams (VILLAGE JIM) pleaded guilty to a charge of causing interference issued under the provisions of Rule 163(1)(a) for having shifted out when not sufficiently

clear of MIDNIGHT CHILL which was contacted and broke gait. Mr Williams had his reinsperson's licence suspended for twenty five days to take effect following his driving engagements on Saturday 17<sup>th</sup> February 2007.

Stewards inquired into the reason for VILLAGE JIM (Grant Williams) being inconvenienced in the run to the finish. Ryna Bell (BAYETE NKOSI) was reprimanded for causing crossing under the provisions of Rule 163(1)(a) for having shifted out when not clear of VILLAGE JIM causing that gelding to be checked.
