### **Stipendiary Stewards Report**

#### **Race 1: KATHLEEN CONGERTON MEMORIAL STAKES (2130 MBL)**

JAYDEE BARTON – (David Gravolin) was severely checked behind a tiring runner racing in the back straight on the final occasion.

IRON CLAD LOMBO – (Morgan Woodley) performed poorly to finish a considerable distance for the majority of the field. A post veterinary examination revealed no abnormalities. When questioned on the performance, driver explained that after being eased to obtain a trailing position in the one wide line, the gelding commenced to over race. He was then obliged to race wider on the track racing in the front straight to receive the bell and from that point onwards the gelding failed to remain competitive. Trainer Ms Annie Belton advised in her opinion the gelding had over raced when wearing the hood type blinkers for the first time this evening. It now her intention to remove the blinkers for future starts. She was advised that IRON CLAD LOMBO would not be permitted to race in the metropolitan area until such time as its form improved and the gelding was also placed on its last chance to race competitively.

SPORTSMANS LADY – (Martin Wilson) on arrival on course, trainer Martin Wilson advised that the mare was showing signs of being in season. A veterinary examination passed the mare fit to start and an appropriate announcement was made.

MANGO JAM – (Ryan Bell) which began badly, was excluded from the mobile barrier draw.

SHINYDES – (Chris Lewis) raced roughly racing towards the front straight to receive the bell.

#### **Race 2: METRO REAL ESTATE AGENTS HANDICAP (2503 SS)**

BAGGY PANTS – (Kade Howson) galloped out. After being taken inside other runners on straightening, had difficulty obtaining clear running over the concluding stages.

#### **Race 3: GP SOCCEROOS MARES STAKES (2130 MBL)**

BABY MAKER – (Kim Prentice) which began badly, was excluded from the mobile barrier draw.

PARIS HEARTBEAT – (John Jelf) after racing at the lead of the one wide line for the majority of the event, failed to run on over the final 400m.

#### **Race 4: LANCASTER PARK SYNDICATIONS STAKES (2130 MBL)**

MON TEGO BAY – (Wesley Andrews) driver dropped his whip racing into the front straight on the final occasion.

LITTLE FELLA – (Morgan Woodley) failed to run on over the concluding stages.

I LIKE IT – (Chris Lewis) after gaining the lead of the one wide line after 700m, failed to run on over the concluding stages.

#### **Race 5: BE ACTIVE STAKES (2130 MBL)**

FALCON SUNSET – (Kevin Keys) shifted out under pressure in the run to the finish.

DISBANDED – (Ryan Warwick) racing in the back straight on the final occasion, choked down and after being taken into the safety lane collapsed through the rail. The gelding was subsequently euthanased.

ALL IN TECK – (Mark McGuire) was checked racing out of the back straight to receive the bell when the pace in the one wide line eased.

KNIGHT STORMER – (Chris Lewis) was checked racing towards the front straight on the first occasion and then inconvenienced racing out of the back straight to receive the bell. Obtained a late inside run.

EARL OF LOCKSLEY – (Wesley Andrews) driver reprimanded under the provisions of Rule 162(1)(j) for failing to maintain his position behind the barrier until release point. Checked racing out of the back straight to receive the bell when the pace in the one wide line eased.

HILTON ADONIS – (Morgan Woodley) driver reprimanded under the provisions of Rule 162(1)(j) for failing to maintain his position behind the barrier until release point. Severely checked racing out of the back straight to receive the bell when the pace in the one wide line eased.

**Race 6: 2006 LANCASTER PARK 2YO FILLIES DIAMOND CLASSIC FINAL (1730 MBL)**

ADDA COOL MIL – (Susan Roberts) raced roughly racing towards the back straight on the final occasion.

AMONGST ROYALTY – (Chris Lewis) underwent a pre race veterinary examination when it was rumoured that the filly had suffered a stone bruise. The filly was passed fit to start. A post race veterinary examination revealed nothing amiss.

PARSONS PARTY – (Mark Reed) was tightened racing towards the front straight on the final occasion.

THE STEWARDESS – (Colin Brown) hung inwards after the start.

BACK HAND STRIKE – (Jon Gavin) commenced to give ground racing out of the back straight on the final occasion and was severely checked shortly thereafter.

TAHARAS JOY – (Ashleigh Markham) was checked racing out of the back straight on the final occasion.

**General**

Stewards inquired into the reason for BACK HAND STRIKE (Jon Gavin) being severely checked racing out of the back straight on the final occasion. Driver David Young (SAABS SIBLING) was found guilty to a charge of causing interference issued under the provisions of Rule 163(1)(a) and had his reinsperson's licence suspended for a period of thirteen days. In assessing penalty Stewards took into account his driving record and his forthcoming engagements.

Stewards inquired into the reason for TAHARAS JOY (Ashleigh Markham) being checked racing out of the back straight on the final occasion. It was established that the filly had made ground to the inside of SAABS SIBLING however that filly had shifted inwards slightly with runners crossing from wider on the track.

**Race 7: COLLETT REALTY HANDICAP (2503 SS)**

MAGNEATO – (Clinton Hall) which began badly, was excluded from the Standing Start draw.

RENOUNCED – (Nigel Johns) obtained an inside run over the concluding stages.

TURKISH – (Aaron Beckett) obtained an inside run over the concluding stages.

SQUATNOVA – (Colin Brown) driver was reminded of his obligations when shifting ground for momentarily inconveniencing a runner racing in the front straight on the final occasion.

GOOD HEAVENS HOLMES – (Mark Reed) was momentarily inconvenienced racing in the front straight on the final occasion.

CLINTONS CIGAR – (Kim Prentice) shifted outwards slightly under pressure in the run to the finish.

DION MORRIS – (Ryan Warwick) galloped out.

ALBERT RAINER – (Gary Hall Jnr) which galloped out, will remain excluded from the Standing Start draw.

**Race 8: CLICK STAKES (1730 MBL)**

OUR SAFELY STAR – (Colin Brown) failed to run on over the concluding stages.

BIG RIVER HANOVER – (Chris Lewis) after racing three wide throughout, failed to run on over the concluding stages.

TRUCKERS WARRIOR – (Murray Hansen) was unable to obtain clear running to the finish.

**Race 9: BAZZO REAL ESTATE STAKES (2130 MBL)**

IACOCCA – (Ryan Warwick) after racing at the lead of the one wide line, failed to run on over the concluding stages.

ARABARAMA – (David Gravalin) was slightly out of position at release point. Driver was reminded of his obligation to maintain his position until the start was effected.

**Race 10: ROY WESTON PROPERTY CENTRE CLAIMING STAKES (2130 MBL)**

JUSTLIKEJOSH – (Rardi Barber) driver was reminded of his obligations regarding whip use when his drive was out of contention.

THAT'S SPECIAL – (Colin Brown) gave ground over the concluding stages.

SON OF A BEACH – (Martin Wilson) after racing at the lead of the one wide line, gave ground over the concluding stages.

STANLEY MOORE – (Clinton Hall) was claimed.
