Race 1: BEYOND TOMORROW PACE (2503 SS)

EM PEE – (Wayne Sharrett) was a late withdrawal at 5.01pm prior to the commencement of betting after trainer Wayne Sharrett advised he was experiencing transport difficulties en route to the course. Under the circumstances no penalty was imposed.

HOT CURRIE – (Aaron Skalecki) which began badly was placed on its last chance in the draw.

MATTS CAB SAV – (Bob Sangalli) which gave ground over the concluding stages will not be permitted to race in the metropolitan area until such time as it has shown form in country areas.

PURPLE PARSNIP – (Chris Lewis) galloped out.

BROOKLYN ROAD – (Jarrad Humphries) after racing at the lead of the one wide line, gave ground over the concluding stages.

Race 2: DANCING WITH THE STARS STAKES (2143 MBL)

ROSEWOOD JERLIN – (Bob Sangalli) commenced slowly and then gave ground over the concluding stages. A post race veterinary examination revealed nothing amiss. Trainer Bob Sangalli was advised that the mare would not be permitted to race in the metropolitan area until such time as it had demonstrated country form. Mr Sangalli advised that the mare would be retired.

Race 3: TODAY TONIGHT TROTTERS PACE (2907 SS)

The start of this race was delayed several minutes due to the malfunction of the 50m starting apparatus.

WONGALA JOLTER – (Colin Brown) a pre race veterinary examination revealed the mare to be showing signs of being in season.

MAORI MAXIMUS – (Chris Lewis) was held up until approaching the 100m mark.

SUPER LUMBER MAN – (Wayne Reid) which broke on two occasions in running will not be permitted to race for six days and until such time as it completes a satisfactory trial.

EXUBERANT – (Andrew De Campo) broke racing in the back straight on the final occasion. It was subsequently established that the hood type blinkers had become displaced. Under the circumstances no action was taken.

PUNTERS REVENGE – (Beau Tindale) which performed poorly was placed on its last chance to race competitively.

Race 4: GREYS ANATOMY STAKES (2143 MBL)

OMANAWA JAMIE – (Brad Stampalia) which gave ground over the concluding stages was placed on its last chance to race competitively.

PIGGY – (Brian Kersley) was checked behind a tiring runner from the 600m to the 400m.

CLASS MASTER – (Kim Young) was inconvenienced by a tiring runner from the 600m to the 400m.

Race 5: LOST STAKES (2143 MBL)

WILL TO LIVE – (Michael Tenardi) had difficulty obtaining clear running over the concluding stages.

Race 6: 2006 SEVEN NEWS PACE (2143 MBL)

CRAB STICK – (Stephen Miller) which commenced to over race racing into the front straight to receive the bell was retired from the event approaching the 600m. A post race veterinary examination revealed nothing amiss. Driver Stephen Miller reported that the gelding had choked down. CRAB STICK will not be permitted to race for six days and until such time as it completes a satisfactory trial.

Race 7: DESPERATE HOUSEWIVES STAKES (2143 MBL)

TERRIFIC SON – (Kade Howson) had difficulty obtaining clear running to the finish.
MISTER BOCELLI – (Andrew De Campo) had difficulty obtaining clear running to the finish.
RIDE SALLY RIDE – (James Schrader) was unable to obtain clear running to the finish.

Race 8: MCINERNEY FORD FIESTA PACE (2102 SS)

SWAPS – (Vance Stampalia) the removable deafeners failed to release.
JACK FORCE – (Clinton Hall) galloped out.
EFFORTLESS – (Gregory Schofield) galloped out.
AACHEN UPP – (Nicole Cross) after racing three wide for the majority of the event, gave ground over the concluding stages.
ULTIMATE SIN – (Nigel Johns) after racing three wide for the majority of the event, gave ground over the concluding stages.
DEE CAMPESE – (Brenton Williams) raced roughly racing out of the back straight on the first occasion.
THE OLD CAMP – (Chris Lewis) raced roughly shortly after the start.
ALBERT RAINER – (Callan Suvaljko) commenced slowly.
CRYSTAL JOURNEY – (Grant Williams) had difficulty obtaining clear running until the final 50m.

Race 9: COMMANDER IN CHIEF PACE (2907 SS)

AFTER THE RAIN – (Nicolaas Van Der Snoek) galloped out.
IL CASINO – (Justin Prentice) which stood flat-footed at the start was excluded from the Standing Start draw.
AUSSIE ATTACK – (Colin Reeves) was severely checked at the start.
COOGEE BELLE – (Kate Kersley) was unable to obtain clear running to the finish.
EARL OF LOCKSLEY – (Callan Suvaljko) galloped out and then was checked shortly after the start. After being obliged to race wider on the track racing into the front straight to receive the bell accidentally contacted a sulky wheel and raced roughly when being restrained to a position.

Race 10: PRISON BREAK STAKES (2548 MBL)

LEFT A COOKIE – (Clinton Kimes) after leading the event gave ground over the concluding stages.
CLUTCH CARGO – (Aaron Goulden) was checked behind a tiring runner from the 400m to the 200m and then had difficulty obtaining clear running over the concluding stages.
LIVERINGA – (John Jelf) was checked behind a tiring runner from the 400m to the 200m and then had difficulty obtaining clear running over the concluding stages.
