#### **Race 1: PUNT AND PUTT COMPETITION 2YO STAKES (1730 MBL)**

MY STRIKING JET – (Chris Lewis) pulled hard for the majority of the event and then was unable to obtain a clear run to the finish.

CHOOKS REWARD – (Colin Brown) shifted up the track slightly under pressure in the run to the finish.

FIVE TIN LIDS – (Shannon Suvaljko) was held up until obtaining an inside run in the latter stages.

#### **Race 2: DANKZ FURNITURE STAKES (2536 MBL)**

SEAFIELD UNICORN – (Shannon Suvaljko) after leading gave ground from the 400m.

OUR CHRISTIE LEE – (Grant Williams) shifted outwards under pressure in the run to the finish.

#### **Race 3: FORCE EQUIPMENT HANDICAP (2503 MBL)**

SANA SANO – (Justin Prentice) galloped out.

TURKISH – (Callan Suvaljko) the near side rein became caught in the quick hitch sulky attachment shortly after the start placing the driver at a disadvantage throughout.

OUR SAFELY STAR – (Colin Brown) was unable to obtain a clear run to the finish.

ARABARAMA – (Mark Reed) galloped briefly at the start.

SEELSTER CUT – (Nicolaas Van Der Snoek) hung inwards momentarily racing out of the back straight on the final occasion.

ALBERT CHIEF – (Gary Hall Jnr) pulled hard in the middle stages after gaining the lead of the event.

IAM CLIVE – (Morgan Woodley) was inconvenienced shortly after the start.

ONAVENTURE – (Ryan Hryhorec) galloped out and was then severely checked shortly afterwards. Unable to obtain a clear run to the finish.

MISSISSIPPI DELTA – (Kim Prentice) was severely checked shortly after the start.

WALLY WIZARD – (Richard Polak) was severely checked racing out of the back straight on the final occasion.

CLASS MATE – (Errol Ashcroft) which began badly was placed on its last chance in the standing start draw.

#### **General**

Stewards inquired into the reason MISSISSIPPI DELTA (Kim Prentice) and ONAVENTURE (Ryan Hryhorec) were severely checked shortly after the start. Nicolaas Van Der Snoek (SEELSTER CUT) was found guilty to a charge of causing interference issued under the provisions of Rule 163(1)(a) for having shifted in when not clear of MISSISSIPPI DELTA and had his reinspersons licence suspended for 28 days.

#### **Race 4: BETTY BROWN MEMORIAL 3YO STAKES (1730 MBL)**

MARLEDO – (Kim Prentice) was unable to obtain a clear run to the finish.

**Race 5: SLATER GARTRELL MARES STAKES (1730 MBL)**

ANGRYLITTLEBEAVER – (Ashleigh Markham) accidentally made contact with a sulky wheel and raced roughly when being eased wider on the track approaching the finish.

ELECTRACITED – (Ryan Warwick) after racing at the lead of the one wide line failed to run over the concluding stages to finish some distance from the remainder of the field. A post race veterinary examination revealed no abnormalities. Trainer Mrs Carol Warwick reported that the mare had been freshened for the 1730m of tonight's event however had been unsuited by the early pace.

**Race 6: 2006 HOWARD PORTER MEMORIAL (2130 MBL)**

ACE OF SPADES – (Clinton Kimes) raced roughly racing out of the back straight on the first occasion.

MORGANATOR – (Donald Harper) failed to run on over the concluding stages.

COSMIC FLIGHT – (Shannon Suvaljko) the driver reported that the sulky seat became detached from the sulky at the 600m placing him a disadvantage for the remainder of the race.

HILTON ADONIS – (Ryan Warwick) hung outwards from approaching the front straight on the final occasion.

BUCK THE ODDS – (Mark Reed) the driver dropped his whip on straightening.

**Race 7: 2006 WINTER CHAMPIONSHIP FINAL (2130 MBL)**

MOMENT IN TIME – (Justin Prentice) was unable to obtain a clear run to the finish.

**Race 8: FRANKHO FOODS STAKES (2536 MBL)**

This race was run in heavy rain

DUCATI – (Chris Lewis) after being taken three wide in the middle stages was unable to obtain a position closer to the marker pegs before giving ground over the concluding stages.

LUCKY PUNCH – (Ryan Bell) after gaining the lead of the one wide line mid race failed to run on over the concluding stages.

**Race 9: LJ HOOKER ATWELL HANDICAP (2503 SS)**

OTTWAY – (Ryan Warwick) shifted outwards under pressure in the run to the finish.

RYLEE JO – (Clinton Kimes) which began badly was excluded from the standing start draw.

SOVEREIGN FELLA – (Beau Tindale) which began badly was placed on its last chance in the standing start draw.

THE ARCH DEACON – (Darren Kerr) which began badly will remain excluded from the standing start draw.

FREDDY RAMA – (John Filardo) which began badly will remain excluded from the standing start draw. When driving out to the finish the driver became momentarily unbalanced. He was advised to modify his whip action to prevent a reoccurrence in similar circumstances.

**Race 10: BE ACTIVE TROTTERS DISCRETIONARY HANDICAP (2503 SS)**

THE FREQUENT FLYER – (Andrew De Campo) which broke racing towards the back straight on the first occasion was placed on its last chance to race truly.

SUN OF ZOLA – (Bob Mellsop) on arrival on course trainer Bob Mellsop reported that the gelding had sustained an injury to the near hind in a stable accident. The gelding underwent two veterinary examinations and was passed fit to start. Broke racing towards the back straight on the first occasion and was placed on its last chance to race truly.

EXUBERANT – (Ryan Bell) was unable to obtain a clear run until the late stages.

COUNT THE LUTE – (Callan Suvaljko) which broke racing towards the winning post on the first occasion was placed on its last chance to race truly. The gelding returned having cast both hind shoes.
