Race 1: TOYOTA PARTS MANAGERS 2YO STAKES (1730 MBL)

PARSONEMBY – (Callan Suvaljko) shifted outwards slightly in the back straight on the final occasion.
KAY WHY SLICK – (Sam Torre) which broke racing into the back straight on the first occasion, will not be permitted to race for six days and until such time as it completes a satisfactory trial. The gelding raced roughly for the major part of the event before giving ground over the concluding stages. A post race veterinary examination revealed nothing amiss. Trainer Sam Torre advised that he had been extremely disappointed with the performance of the gelding, which would now be spelled.
BARNETT ON LINE – (Vance Stampalia) contacted a sulky and raced roughly racing in the back straight on the final occasion.

Race 2: TOYOTA SERVICE MANAGERS STAKES (2130 MBL)

The Starter was obliged to turn the field away at the first attempt at the score up when the tongue-tie on ABERCROMBIEDREAMER (Chris Lewis) became detached
WEONA SHOWDOWN – (Mark Reed) had difficulty obtaining clear running to the finish.
J DS BEAU – (Adam Nafranec) raced three wide throughout.
ANOTHER NOTCH UP – (Aldo Cortopassi) raced three wide with cover throughout.
NOBLE CHEVALIER – (Ryan Bell) was held up until passing the 100m.

Race 3: TOYOTA FINANCIAL SERVICES STAKES (2130 MBL)

CLIP THE TICKET – (Ben Keiley) which began badly and trailed the field throughout, was excluded from the mobile barrier draw.
SCENIC SAGA – (Kim Young) was unable to obtain clear running until the 100m.
JUST BELLA – (Jarrad Humphries) was checked at the start.

Race 4: TOYOTA WA DISTRIBUTOR STAKES (2536 MBL)

O K SMOOTHIE – (Beau Tindale) locked wheels racing into the front straight on the final occasion.
SWAPS – (Kade Howson) failed to run on over the concluding stages.
NAT TRICK – (Craig Saligari) failed to run on over the concluding stages.
VIEW TO A KILL – (Clinton Hall) was out of position at release point. The driver was fined \$100 under the provisions of Rule 163(1)(h) for having failed to come up into position.
JACCKA FROST – (Chris Lewis) locked wheels racing into the front straight on the final occasion.

Race 5: TOYOTA GENUINE ACCESSORIES MARES STAKES (1730 MBL)

This race started several minutes after the advertised start time due to THEEYES TELLNOLIES (Craig Goldfinch) sustaining a flat tyre during its preliminary.
ALBERTS GIRL – (Kate Kersley) raced three wide throughout.
SANA SANO – (Kim Prentice) was unable to obtain clear running to the finish.
CLASSY AND SMART – (Kade Howson) failed to run on over the concluding stages.

Race 6: TOYOTA DEALER NETWORK STAKES (2536 MBL)

CAMBERTIE – (Ashleigh Markham) pulled hard in the middle stages.

ULTIMATE SIN- (Morgan Woodley) was momentarily inconvenienced racing into the front straight on the final occasion.

ALL IN TECK – (Mark McGuire) pulled hard for the major part of the event.

Race 7: 2006 TOYOTA GENUINE PARTS, SERVICE & ACCESSORIES STATE SIRES SERIES 3YO COLTS & GELDINGS FINAL (2130 MBL)

A computer malfunction 5m into the score up obliged the Starter to complete the starting procedure manually. CAPRICORN CRUISER – (Gary Hall Jnr) which broke free of interference racing out of the back straight on the first occasion, will not be permitted to race for six days and until such time as it completes a satisfactory trial. Was unable to obtain clear running to the finish.

DEVASTATING – (Chris Lewis) pulled hard when racing at the lead of the one wide line.

HOT OR WHAT – (Shane Butterworth) was unable to obtain clear running to the finish.

PARKYS DILEMMA – (Robert Cassian) was inconvenienced racing out of the back straight on the first occasion and was retired from the event in the back straight on the final occasion. A post race veterinary examination revealed the colt to have suffered atrial fibrillation. Trainer Mr R Cassian was advised that PARKYS DILEMMA would not be permitted to race for six days and until such time as it completes a satisfactory trial.

SUPREME VINTAGE – (Mark Reed) was inconvenienced racing out of the back straight on the first occasion.

Race 8: R.V. RUNAWAY VACATION CONDITIONED HANDICAP (2503 SS)

MYSTYS GIRL – (Mark Reed) galloped briefly at the start.

BIG RIVER HANOVER – (Chris Lewis) galloped out.

MAGNEATO – (Aldo Cortopassi) was checked racing out of the front straight on the final occasion.

MACHINE GUN – (Jarrad Humphries) galloped out.

WIMPLE DIMPLE – (Kade Howson) galloped out.

SURPRISE MAKER – (Brad Stampalia) galloped briefly at the start, hung inwards racing out of the front straight on the final occasion.

ISRALIES SON – (Shane Butterworth) galloped briefly at the start.

Race 9: TOYOTA CUSTOMER SERVICES STAKES (2536 MBL)

AM I TOUGH – (Hayden Charles) after leading for the majority of the event, failed to run on over the concluding stages.

ACE OF SPADES – (Ryan Warwick) was retired from the event in the final lap after commencing to give ground. A post race veterinary examination revealed the gelding to have suffered atrial fibrillation. Trainer Mr Cameron Edwards was advised the ACE OF SPADES would not be permitted to race for six days and until such time as it completes one satisfactory trial.

THE DIE IS CAST – (Vance Stampalia) was inconvenienced behind a tiring runner in the front straight to receive the bell.

JAILBIRD – (Kim Prentice) was held up until obtaining an inside run over the concluding stages.

Race 10: KEEP THE FEELING TROTTERS DISCRETIONARY HANDICAP (2503 SS)

The start was delayed for several minutes due to the dustsheet on RISK AND REWARD (Shane Young) requiring repair.

RISK AND REWARD – (Shane Young) galloped out, broke racing towards the back straight on the first occasion. The gelding was placed on its last chance to race truly.

MAORI MAXIMUS – (Chris Lewis) which began badly will remain excluded from the Standing Start draw. Placed on its last chance to race truly after breaking in the back straight on the first occasion.

MACLADDIE – (Kim Young) which broke racing towards the front straight on the final occasion, was placed on its last chance to race truly. Unable to obtain clear running to the finish.

OPULENCE – (Kate Kersley) which began badly, was placed on its last chance in the draw.

EXUBERANT – (Ryan Bell) which began badly, was excluded from the Standing Start draw. The gelding which then performed poorly before being retired from the event, will not be permitted to race for six days and until such time as it completes a satisfactory trial.

DAVE STAR – (Dave Mellsop) was checked and broke gait shortly after the start.
