Stipendiary Stewards Report

Race 1: MORE 'F' IN FUN MARES HANDICAP (2503 SS)

ZESTY LOMBO – (Gary Hall Jnr) which began badly, was placed on its last chance in the draw. Severely checked racing out of the front straight on the first occasion when obliged to race inside the line of the marker pegs before being restrained to a position.

BONNY MAC – (Chloe Tindale) baulked at the barrier strand and galloped briefly at the start.

SMOOTH VIEW – (Callan Suvaljko) was held up in the early stages and then when attempting to gain an inside run, was tightened and raced inside the line of the marker pegs for a short distance in the front straight on the final occasion.

ALBERTS GIRL - (Colin Brown) was checked racing into the back straight on the first occasion.

JUST BELLA – (Jarrad Humphries) was checked racing into the back straight on the first occasion and obliged to race wider on the track before going forward to lead the one wide line.

JESSICA CLARE - (Mark Reed) which began badly, will remain excluded from the Standing Start draw.

General

Ross Keys driver of the fourth placed BEST WEST protested against BONNY MAC (Chloe Tindale) being awarded the race on the grounds of that mare making ground whilst galloping at the start. After taking evidence from the drivers involved, acting on their own observations and viewing the films of the incident, Stewards dismissed the protest and gave All Clear on the Judge's numbers of 2,8,1,3,7 & 9. Mr Keys was fined \$200 under rule 180 for having lodged a frivolous protest.

Stewards inquired into the reason for ZESTY LOMBO (Gary Hall Jnr) being obliged to race inside the line of the marker pegs racing out of the front straight and towards the back straight on the first occasion before being restrained to a position back in the field. Driver Ross Keys pleaded guilty to a charge issued under the provisions of Rule 163(1)(d) of obliging ZESTY LOMBO to race inside the marker pegs and had his reinsperson's licence suspended for twenty four days. In determining penalty, Stewards took into account his guilty plea and driving record.

Stewards inquired into the reason for ALBERTS GIRL (Colin Brown) and JUST BELLA (Jarrad Humphries) being checked racing into the back straight on the first occasion. Gary Hall Jnr (ZESTY LOMBO) pleaded guilty to a charge of causing interference when re-entering the true running line after being obliged to race inside the line of the marker pegs (Rule 163(2)) and had his reinsperson's licence suspended for fourteen days to take effect following his drives on Tuesday 27th June 2006. In assessing penalty, Stewards took into account his guilty plea and excellent driving record.

Stewards inquired into the reason for SMOOTH VIEW (Callan Suvaljko) being tightened and obliged to race inside the line of the marker pegs for a short distance racing in the front straight on the final occasion. Driver Ross Keys (BEST WEST) pleaded guilty to a charge issued under the provisions of Rule 163(1)(d) of obliging SMOOTH VIEW inside the line of the marker pegs and has his reinsperson's licence suspended for a period of fifteen days. Stewards ruled that the penalty would run concurrently with the previously imposed suspension.

Race 2: COLLEX PEOPLE PLANET STAKES (2130 MBL)

ABERCROMBIEDREAMER – (Callan Suvaljko) after leading, failed to run on over the concluding stages. Stewards will question trainer Callan Suvaljko on the performance.

MARTIN CASH – (Gary Hall Jnr) failed to run on over the concluding stages.

Race 3: BE ACTIVE STAKES (2536 MBL)

MACHINE GUN – (Chris Lewis) hung inwards racing out of the back straight on the final occasion.

FAKE EMBRACE – (Justin Prentice) raced roughly racing out of the back straight on the first occasion and then failed to run on over the latter stages.

PERFECT ORDER – (Colin Brown) failed to run on over the concluding stages.

Race 4: COLLEX WASTE MANAGEMENT STAKES (2536 MBL)

FIRE AND BRIMSTONE - (Jason Vella) was unable to obtain clear running until passing the 100m.

NAT TRICK – (Craig Saligari) was checked racing out of the front straight on the first occasion.

I AM CLIVE – (Morgan Woodley) was held up until obtaining an inside run near the 100m.

VILLAGE BONUS - (Grant Williams) was held up until approaching the 100m.

General

Stewards inquired into the reason for NAT TRICK (Craig Saligari) being checked racing out of the front straight on the first occasion. After taking evidence from drivers Craig Saligari, Morgan Woodley (I AM CLIVE) and Wesley Andrews (ALBERT RAINER) driver Morgan Woodley was give the benefit of the grave doubt as to whether he had been fully responsible for the incident.

Race 5: DBC TENDER RIDGE 3YO STAKES (1730 MBL)

FLUENT STYLE – (Gregory Schofield) was held up on straightening and shortly afterwards made contact with a sulky before angling inwards.

GO ON TEMPT ME – (Ashleigh Markham) failed to run on over the concluding stages.

TOMS FELLA – (Kevin Keys) pulled hard for a major part of the event when racing behind the leader.

EVEN DROP - (Jeffrey Wegner) after racing three wide, failed to run on over the concluding stages.

DISCO INVASION – (Raymond Jones) made contact with several marker pegs in running. Driver advised to make a greater effort to avoid contacting marker pegs.

BACK IN THE BLACK - (Ryan Warwick) failed to run on over the concluding stages.

Race 6: 2006 COLLEX 2YO COLTS & GELDINGS PEARL CLASSIC FINAL (2130 MBL)

ADDA DOUBLE DIP – (Susan Roberts) raced keenly in the latter stages of the score up, and then had a tendency to pull hard for a major part of the race.

BARJHOBIL – (Ryan Warwick) which began badly, was excluded from the mobile barrier draw until such time as it has completed four satisfactory race or trial starts. Driver advised to ensure runners to his inside had sufficient racing room when shifting position as he momentarily tightened another runner racing off the back straight on the final occasion.

AKASAN - (Callan Suvaliko) momentarily tightened racing out of the back straight on the final occasion.

Race 7: COLLEX – A SUBSTAINABLE FUTURE STAKES (2130 MBL)

KNIGHT STORMER – (Chris Lewis) after leading and being pressured, failed to run on over the concluding stages.

IONTHEBALL – (Clinton Hall) after working forward in quick time to gain the lead of the one wide line, failed to settle for the majority of the event.

Race 8: NOVA 93.7 HANDICAP (2503 SS)

TURKISH – (Wesley Andrews) galloped briefly at the start.

RUMOR HAZIT – (Gregory Schofield) which began badly, was placed on its last chance in the draw.

CLINTONS CIGAR – (Kim Prentice) failed to run on over the concluding stages. A post race veterinary examination revealed nothing amiss. When questioned on the performance trainer/driver Kim Prentice advised that the gelding had been slightly disappointing, however had not been suited by racing wider on the track over the final stages. It was now his intention to increase the gelding's workload.

ALL IN TECK – (Mark McGuire) failed to obtain clear running until passing the 100m.

Race 9: COLLEX RECYCLING STAKES (2130 MBL)

LASPANGOINPARIS - (Glen Richards) which began badly, was excluded from the mobile barrier draw.

PERIPHERIQUE - (Michael Tenardi) failed to run on over the concluding stages after racing three wide throughout.

HOT CURRIE - (Donald Harper) which began badly, was excluded from the mobile barrier draw.

Race 10: TOYOTA GENUINE PARTS, SERVICE & ACCESSORIES TROTTERS STAKES (2130 MBL)

CHEW TOBACCO BAY – (Terry Wegner) failed to run on over the concluding stages.

EARLY STRIKER – (Matthew Scott) which broke racing towards the front straight on the final occasion, will not be permitted to race for six days and until such time it completes a satisfactory trial.

MACLADDIE – (Kim Young) failed to run on over the concluding stages.
