#### **Race 1: MILLSY & TONY MAC STAKES (2536 MBL)**

LEADING STAR – (Callan Suvaljko) racing out of the front straight on the first occasion when being eased to obtain a position closer to the marker pegs, accidentally made contact with the sulky wheel of DARK SHADOW (Ben Keiley) and broke gait. A factor in this incident was DARK SHADOW being eased at that point. Under the circumstances, no action was taken.

CUMBRIA WARRIOR – (Gary Hall Jnr) was unable to obtain a clear run to the finish.

PERIPHERIQUE – (Michael Tenardi) was unable to obtain a clear run to the finish.

#### **Race 2: BOB MAUMILL PATHWAY SERIES STAKES (1730 MBL)**

OCHIL HILLS – (Morgan Woodley) was unable to obtain a clear run to the finish.

SERIAL PEST – (Callan Suvaljko) shifted up the track under pressure in the run to the finish. Driver reprimanded and advised to make a greater effort to straighten his drive.

EXCEEDINGTHELIMIT – (Wesley Andrews) had difficulty obtaining a clear run to the finish.

DEVASTATING – (Chris Lewis) hung inwards momentarily shortly after the start.

#### **Race 3: HOWARD SATTLE R STAKES (2130 MBL)**

MATT IN BLACK – (Nathan Turvey) when questioned on his driving tactics, in particular his reasons for failing to obtain a trailing position in the three wide line, racing towards the back straight on the final occasion, driver explained that at that stage he had been trailing the two fancied runners. As the gelding had risen sharply in class for tonight's event rather than being carried wide, he felt his best option was to attempt to make ground inside runners when the fancied runners made their outward moves.

ETOILE DU NORD – (Wesley Andrews) driver reminded of his obligations for the manner in which he shifted ground in the front straight on the final occasion.

ALL RAPT UP – (Colin Brown) was momentarily inconvenienced in the front straight on the final occasion when runners shifted to his inside.

#### **Race 4: XXXX GOLD NUGGET PRELUDE 1 (2130 MBL)**

A protest by Kade Howson driver of the fourth placed MR YANKEE against the third placed DEBT PROPELLED (Vance Stampalia) alleging interference racing out of the back straight on the first occasion was dismissed.

MR YANKEE – (Kade Howson) checked racing out of the back straight on the first occasion.

RADAR SMOKING GUN – (Ryan Bell) was out of position at release point. Driver was reprimanded and advised that a repetition would result in more serious action being taken against him.

SONNY OLDGOULBURN – (Ryan Warwick) failed to run on over the concluding stages.

#### **General**

Stewards inquired into the reason for MR YANKEE (Kade Howson) being checked racing out of the back straight on the first occasion. Vance Stampalia (DEBT PROPELLED) pleaded guilty to a charge of causing interference issued under the provisions of Rule 163(1)(a) and his reinsperson's licence was suspended for a

period of twenty one days to take effect from midnight. In assessing penalty, Stewards took into account Mr Stampalia's driving record and his guilty plea.

**Race 5: GARY SHANNON STAKES (2130 MBL)**

SMOOTH ADVANCE – (Matthew Scott) was unable to obtain a clear run to the finish.  
ITS NO FAKE – (Morgan Woodley) had a tendency to over race when leading.  
CHELSEA VILLAGE – (Grant Williams) was unable to obtain a clear run to the finish.

**Race 6: 2006 882 6PR NAVY CUP (2503 SS)**

RICHARD HENRY – (Colin Brown) raced roughly at the start.  
OK WINDERMERE – (Mark Reed) had difficulty obtaining a clear run to the finish.  
MUSTANG FIGHTER – (Callan Suvaljko) galloped out.

**Race 7: HMAS STIRLING STAKES (2130 MBL)**

NEXT TIGER – (Michael Tenardi) had a tendency to over race when leading. Shifted out under pressure in the run to the finish.  
FINEGANS WAKE – (Colin Brown) failed to run on over the concluding stages.  
JACCKA FROST – (Chris Lewis) obtained an inside run to the finish.

**Race 8: KARRI VALLEY RESORT STAKES (2130 MBL)**

COLONIAL BLAZE – (Aaron Skalecki) was unable to maintain its position in the latter stages of the score up and as a result was slightly out of position at release point. Pulled hard for a major part of the event, broke racing in the front straight on the final occasion and will not be permitted to race for six days and until such time as it completes a satisfactory trial.  
MOTU FLARE AND STYLE – (Kade Howson) raced roughly shortly after the start when being eased. Unable to obtain a clear run to the finish.  
JUSTABITJOLLY – (Chris Lewis) pulled hard for a major part of the event.  
CONTEPOMI – (Ben Keiley) unable to obtain a clear run to the finish.  
GREATSOUTHERNSTAR – (Mark Reed) was slightly out of position at release point.

**Race 9: 882 6PR SPORTS CENTRAL STAKES (2130 MBL)**

WAKE NED DEVINE – (Kade Howson) was checked racing out of the front straight on the first occasion.  
WEONA SHOWDOWN – (Mark Reed) dropped the offside knee boot shortly after the start and raced roughly racing out of the back straight on the first occasion in consequence.  
TOTAL MOTIVATION – (Morgan Woodley) raced roughly shortly after the start. Raced roughly racing into the front straight to receive the bell.

**General**

Stewards inquired into the reason for WAKE NED DEVINE (Kade Howson) being checked racing out of the front straight on the first occasion. Des Stockman (LOMBO APOLLO) was found guilty to a charge of causing crossing issued under the provisions of Rule 163(1)(a) and had his reinsperson's licence suspended for sixteen days to take effect from midnight.

**Race 10: GRAHAM MABURY PACE (2503 SS)**

HOLME MAKER – (Ryan Warwick) which began badly losing considerable ground, was excluded from the Standing Start draw.  
EASTWOOD STAR – (Glen Richards) galloped briefly at the start.  
RYLEE JO – (Clinton Kimes) which galloped out, will remain excluded from the Standing Start draw.  
EL ROSA – (Callan Suvaljko) which galloped out, will remain excluded Right out of the Standing Start draw.  
AMARYLLIS SPIRIT – (Morgan Woodley) was inconvenienced shortly after the start.  
PAYNIN – (Mark Reed) raced roughly and hung inwards contacting several marker pegs racing into the back straight on the final occasion and again racing into the front straight on the final occasion. A warning was issued. Held up until obtaining a clear run inside the 70m.

**GENERAL**

**Friday 17<sup>th</sup> November 2006, Race 6 2006 PARLIMENTARIANS CUP (2503m SS)**

Stewards inquired into the reason for LENNON (Gary Hall Jnr) being checked racing into the back straight on the final occasion. It was established the gelding had raced in restricted room for some distance, outside

GEE WHIZ FIZZ (Ryan Warwick) and inside LIGHTNING JAKE (Shane Butterworth). Due to the general shifting of runners, Stewards were unable to apportion blame for the incident to individual drivers and took no action over the matter.
