Stipendiary Stewards Report

RACE 1: CHANNEL NINE 2YO STAKES (1730 MBL)

BAILEY DYLAN – (Beau Tindale) began badly, was excluded from the mobile barrier draw.

RUBY DAZZLER – (Grant Williams) had a tendency to hang outwards at various stages and racing out of the front straight on the first occasion raced roughly for a short distance. Severely checked, racing out of the front straight on the final occasion losing considerable ground.

JACCKA LONDONDRY – (Kade Howson) hung outwards and broke racing out of the front straight on the final occasion losing considerable ground. Will not be permitted to race for six days and until such time as it completes a satisfactory trial.

SILVER TAIL ADDA – (Aaron Beckett) checked racing into the front straight on the final occasion.

QUITE LOADED – (Gary Hall Jnr) raced roughly racing towards the front straight to receive the bell. Severely checked racing into the front straight on the final occasion.

General

Stewards inquired into the reason for QUITE LOADED (Gary Hall Jnr) being severely checked racing towards the front straight on the final occasion. Aiden Warwick (EZY FELLA) was found guilty to a charge of causing interference issued under the provisions of Rule 163(1)(a) for having shifted in when not sufficiently clear of SILVER TAIL ADDA (Aaron Beckett) carrying that gelding in onto QUITE LOADED. Mr Warwick had his reinspersons's licence suspended for a period of twenty one days. Stewards inquired into the reasons for SILVER TAIL ADDA (Aaron Beckett) being checked racing into the front straight on the final occasion. Aiden Warwick (EZY FELLA) was found guilty to a charge of causing interference issued under the provisions of Rule 163(1+)(a) and had his reinspersons's licence suspended for twenty three days. Stewards ruled that both penalties would be served concurrently and would take effect following Mr Warwick's driving engagements on Tuesday 29th May 2007.

RACE 2: SIDCHROME PATHWAY SERIES STAKES (2130 MBL)

VILLAGE LORD – (Shane Young) unable to obtain a clear run to the finish.

LEEHLME – (Jarrad Humphries) after racing at the lead of the one wide line for a major part of the event, failed to run on over the concluding stages. A post race veterinary examination revealed no abnormalities. Trainer/driver explained that in his opinion the gelding had over raced when leading the one wide line and it was now his intention to effect gear changes in an effort to make LEEHLME race tractably. In addition he would place the horse in country class races for a period. LEEHLME was placed on its last chance to race competitively.

MIKE WAZOWSKI – (Morgan Woodley) inconvenienced behind a tiring runner racing towards the front straight on the final occasion.

RACE 3: STAN ENNIS STAKES (2130 MBL)

The Starter was obliged to call a false at the first attempt when the near side rein became caught in the quick hitch attachment on the sulky of BACKSEAT DREAMER. Trainer/driver Grant Williams was advised to fit a neck strap to prevent a re-occurrence.

BROOKLYN ROAD – (Brian Kersley) over raced for a major part of the event.

HER MAN MURRAY – (Ryan Warwick) driver lost his whip at the 300m mark.

OHOKA JAZ – (Justin Prentice) unable to obtain a clear run to the finish and in the driver's efforts to improve his position locked sulky wheel hubs with another runner in the front straight on the final occasion.

BACKSEAT DREAMER – (Grant Williams) locked sulky wheel hubs with another runner in the run to the finish.

RACE 4: BE ACTIVE STAKES (1730 MBL)

The start of this race was delayed several minutes, as KENDALL CASTLE (Morgan Woodley) required a slight gear adjustment at the barrier.

KALUGA – (Ryan Warwick) which had not raced since August 2006 underwent a precautionary veterinary inspection on arrival and was passed fit to start. Unable to obtain a clear run to the finish.

MORGANATOR – (Justin Prentice) hung inwards racing out of the front straight on the first occasion.

RACE 5: "SOVEREIGN BEEJAY" DISCRETIONARY HANDICAP (2503 SS)

LEACRAIG – (Michael Sangalli) galloped out.

JAKE THE MUS – (Chris Lewis) galloped out.

ONAVENTURE – (Callan Suvaljko) galloped out.

JAILBIRD – (Kim Prentice) galloped out and was checked shortly after the start. Locked sulky wheel hubs with another runner for a short distance on straightening.

ALL IN TECK – (Grant Williams) jumped sideways at the start and galloped out. Locked sulky wheel hubs with another runner for a short distance on straightening.

NATS NIFTY – (Phillip Duggan) began badly and will remain excluded from the Standing Start draw. Failed to run on over the concluding stages.

RACE 6: RYOBI STAKES (2130 MBL)

EARL OF LOCKSLEY – (Chris Lewis) unable to obtain a clear run to the finish.

NO BLUE MANNA – (Aiden Warwick) unable to obtain a clear run to the finish.

FAKING IT – (Colin Brown) having its first race start since November 2005, underwent a precautionary veterinary inspection on arrival on course and was passed fit to start. Unable to obtain a clear run to the finish.

RACE 7: 2007 WASBA BREEDERS STAKES (1730 MBL)

MOMENT IN TIME – (Kim Prentice) unable to obtain a clear run to the finish.

NITRO NINA – (Stephen Reed) the pull up blinkers failed to activate in running.

RACE 8: MAKITA CONDITIONED HANDICAP (2503 SS)

BLACK LINE – (Mark Reed) began badly, placed on its last chance in the Standing Start draw.

TURKISH – (Morgan Woodley) galloped out.

BRYCE CANYON – (Beau Tindale) delayed the start by being fractious and then began badly, placed on its last chance in Standing Start events. Failed to run on over the concluding stages, returned with abrasions to both hind bumpers.

BABY JAMES – (Callan Suvaljko) shifted out under pressure in the run to the finish.

ROCKY ROBINSON – (Shane Young) held up until obtaining clear running passing the 100m.

RACE 9: "ARMBRO INTERCEPT" CONDITIONED HANDICAP (2102 SS)

CHILLI DAWN – (Ryan Warwick) held up until obtaining an inside run inside the 100m.

OTTWAY – (Peter Tilbrook) broke after the start, excluded from the Standing Start draw. Broke the offside hopple shortening mechanism shortly after the start.

CASSIE ROX – (Kevin Keys) shifted out under pressure in the run to the finish.

AZERBAIJAN – (Nigel Johns) failed to run on over the concluding stages.
 LOGAN MICK – (Brad Stampalia) which had not raced since November 2005 underwent a precautionary veterinary examination on arrival on course and was passed fit to start. Severely checked shortly after the start.
 WILLOWLEAF STAR – (Mark Reed) severely checked shortly after the start.
 ON THE AGENDA – (Clinton Hall) commenced slowly and failed to run on over the concluding stages.

RACE 10: DBC TENDER RIDGE JUNIOR DRIVERS STAKES (2536 MBL)

NO SHENANAGANS – (Chris Playle) had difficulty obtaining clear running to the finish.
 ROMAN TRICKSTER – (Justin Prentice) underwent a pre race veterinary inspection after the trainer advised that an abscess to the near fore foot had burst since the gelding's last race start. Passed fit to start.
 SAFE DECISION – (James Schrader) unable to obtain a clear run to the finish.

RACE 5: TOYOTA FINANCIAL SERVICES STAKES (2130 MBL)

When questioned on the driving instructions issued, trainer Steven Burton (GEE WHIZ FIZZ) advised that the gelding, resuming from a spell, had only trialed on one occasion prior to that evening's event and in his opinion, was not sufficiently forward in condition to work hard at both ends of the race. He advised his driver of that fact, however, had not considered it necessary to issue specific instructions.
