Stipendiary Stewards Report

Race 1: SCHWEPPE JUNIOR DRIVERS STAKES (2130 MBL)

NELSON STREET – (Kade Howson) was unable to obtain a clear run to the finish.

CLAIRVAUX – (Morgan Woodley) racing out of the back straight on the second occasion, the gelding collapsed to the inside of the track and lay motionless in the safety lane. The accident warning light were activated and the race continued. A subsequent veterinary examination revealed the gelding to be deceased from a suspected internal haemorrhage. Post mortem swab samples were obtained.

SORRENTO TUESDAY – (David Young) contacted a sulky and broke gait racing in the front straight to receive the bell. Driver will be interviewed regarding the incident.

ELITE ARMBRO – (Stephen Reed) raced roughly and broke gait racing out of the back straight on the first occasion. As the gelding had offended in a similar manner in recent starts, it will not be permitted to race for fourteen days and until such time as it completes two satisfactory trials. Severely checked racing towards the front straight to receive the bell before being retired from the event.

DAYS OF GRACE – (Chris Playle) was out of position at release point. Driver reprimanded under the provisions of Rule 162(1)(h) for having failed to make sufficient effort to maintain his position. Severely checked and fell racing towards the front straight to receive the bell.

DESPERADO SHANNON – (Kody Charles) shied at a fallen horse and broke gait racing towards the front straight to receive the bell. Contacted a sulky and broke racing into the front straight to receive the bell as the pace eased slightly. Driver was advised to be more aware in similar circumstances.

CHILLI DAWN – (Jason Woodworth) was inconvenienced racing towards the front straight to receive the bell, failed to run on over the concluding stages.

Race 2: BURSWOOD ENTERTAINMENT COMPLEX CLAIMING STAKES (2130 MBL)

KENDALL CASTLE – (Morgan Woodley) failed to run on over the concluding stages.

COVENT GARDEN – (Colin Brown) which began badly, was excluded from the mobile barrier draw for four satisfactory race or trial starts.

COBARGO WIND – (Aiden Warwick) failed to run on over the concluding stages.

SEELSTER CUT – (Mark Reed) was momentarily inconvenienced over the concluding stages.

Race 3: BE ACTIVE STAKES (2130 MBL)

JACCKA TANA – (Mark Reed) shifted out under pressure in the run to the finish.

SILENT FIVE – (Shannon Suvaljko) returned having turned both knee boots.

TOALLAGOODKNIGHT – (Gary Hall Jnr) had difficulty obtaining a clear run over the late stages.

Race 4: TOYOTA GENUINE PARTS, SERVICE & ACCESSORIES TROTTERS STAKES (2130 MBL)

ROCKA BILLY – (Ryan Warwick) a post race veterinary examination revealed the gelding to have returned sore in the near hind. ROCKA BILLY will not be permitted to race or trial until a Veterinary Certificate of Soundness is produced.

BONSPIEL STAR – (Kade Howson) commenced slowly, checked racing into the front straight to receive the bell.

RISK AND REWARD – (Aaron Skalecki) severely checked racing into the front straight on the final occasion with the driver momentarily dropping his whip before recovering it.

NACOOKEE – (Natalie Duffy) which broke racing towards the front straight on the final occasion, was placed on its last chance to race truly.

PRIDE OF ALHAMBRA – (Colin Brown) which began badly, trailing the field, was excluded from the mobile barrier draw.

COUNT THE LUTE – (Callan Suvaljko) was severely checked racing towards the front straight on the final occasion.

KEEPER OF DREAMS – (Beau Tindale) was out of position at release. Broke racing into the front straight to receive the bell before being retired from the event. It was subsequently found to have shattered the near fore pastern and was euthanased.

ARMED RAIDER – (Terry Wegner) was checked racing into the front straight to receive the bell.

DAVE STAR – (Bob Mellsop) was severely checked racing into the front straight on the final occasion.

Race 5: CHANNEL NINE STAKES (2130 MBL)

BOBBY HANK – (Justin Warwick) was inconvenienced racing into the front straight on the first occasion. Failed to run on over the concluding stages.

OUR GOLDEN FINALE – (Jason Woodworth) failed to run on over the concluding stages.

AUSSIE ATTACK – (Morgan Woodley) broke gait racing into the front straight to receive the bell. It was subsequently established that the gelding had shied at a marker peg that had been dislodged at that point. Under the circumstances, no action was taken.

KNIGHT STORMER – (Stephen Miller) was inconvenienced racing into the front straight on the first occasion.

DEMORALIZER – (Justin Prentice) which broke gait racing towards the front straight on the first occasion, will not be permitted to race for six days and until such time as it completes a satisfactory trial.

LUCKY PUNCH – (Kade Howson) was inconvenienced racing into the front straight on the first occasion.

Race 6: TOYOTA YARIS HANDICAP (2503 SS)

ONA RAINBOW – (Shannon Suvaljko) was checked at the start.

LONG SHOT LOU – (Timothy Earnshaw) jumped sideways at the start before galloping out.

PAISLEYS MARCH – (Wayne Price) shifted out and was then tightened for room racing out of the front straight on the first occasion.

MOTORING SAM – (Chris Lewis) galloped out, failed to run on over the concluding stages.

IDEAL LAVROS – (Ryan Warwick) was severely checked racing out of the front straight on the first occasion.

TROUBLESCENE – (Jarrad Humphries) was checked at the start.

MOTORING ALDERBARAN – (Kim Prentice) which jumped sideways at the start before galloping briefly, will remain excluded from the Standing Start draw.

General

Stewards inquired into the reason for IDEAL LAVROS (Ryan Warwick) being severely checked racing out of the front straight on the first occasion. Wayne Price (PAISLEYS MARCH) pleaded guilty to a charge of causing crossing issued under the provisions of Rule 163(1)(a) and had his reinsperson's licence suspended for twelve days. In assessing penalty, Stewards took into account Mr Price's guilty plea and his excellent driving record.

Race 7: 2007 JP STRATTON MEMORIAL CUP (2536 MBL)

BUCK THE ODDS – (Kim Prentice) was checked from the 500m to the 400m when carried back by a tiring runner.

CRAB STICK – (Stephen Miller) a post race veterinary examination revealed no abnormalities.

TAIHAPE TICKLER – (Morgan Woodley) which performed poorly, tiring over the final 500m, will not be permitted to race for six days and until it completes a satisfactory trial.

SHARDONS AFLYIN – (Grant Williams) obtained a late inside run.
SPEED MONSTER – (Gary Hall Jnr) shifted out under pressure in the run to the finish.
GEE WHIZ FIZZ – (Ryan Warwick) shifted out under pressure in the run to the finish.

Race 8: 2007 SUMMER GIFT (2130 MBL)

TALK TO ME COURAGE – (Kim Prentice) broke gait racing in the front straight on the final occasion. It was subsequently established that its sulky had clashed with a sulky of another runner shifting ground slightly at that point with the gelding becoming unbalanced as a result. Under the circumstances, no action was taken.
BARJOHBIL – (Aiden Warwick) hung outwards in the score up and broke shortly after the start. Driver reported that in his opinion the colt had got its tongue over the bit in the latter stages of the score up, however BARJOHBIL was excluded from the mobile barrier draw.
LUNAR LYNX – (Morgan Woodley) was slightly out of position at release point. The driver was reminded of his obligations in similar circumstances.
AIKIDO WHITBY – (Chris Lewis) was severely checked shortly after the start. Hung outwards and broke gait racing towards the front straight on the final occasion. Driver was of the opinion that the colt may have contacted a sulky wheel at that point, however AIKIDO WHITBY will not be permitted to race for six days and until such time as it completes a satisfactory trial.

Race 9: THE WEST AUSTRALIAN CONDITIONED HANDICAP (2503 SS)

General

SHELLSTAR (Mark Reed) was withdrawn prior to the start when a pre race veterinary examination confirmed that the gelding had bled from the near side nostril. All bets made on SHELLSTAR were refunded and deductions from winning bets were made in accordance with RWWA Rule of Wagering 56. It was subsequently established that the gelding had struck its head in the float enroute to the course and a further veterinary examination confirmed the gelding to have a minor laceration consisted with this having occurred. Under the circumstances no penalty had been incurred.
MACHINE GUN – (Jarrad Humphries) galloped out.
JAYDEE BARTON – (Shannon Suvaljko) galloped out.
VINTAGE CONCERTO – (Gary Hall Jnr) was inconvenienced racing out of the front straight on the first occasion.
ONAVENTURE – (Callan Suvaljko) galloped out. Failed to run on over the concluding stages.

General

Driver Kim Young (ROCKY ROBINSON) was reminded of his obligations when shifting ground inwards after momentarily inconveniencing another runner racing out of the front straight on the first occasion.

Race 10: SKY CHANNEL MARES STAKES (2130 MBL)

SMOOTH VIEW – (Craig Saligari) was inconvenienced racing towards the front straight on the first occasion.
SHINKANSEN – (Mark Reed) failed to run on over the concluding stages finishing some distance from the remainder of the field. A post race veterinary examination revealed no abnormalities. The mare will not be permitted to race for six days and until such time as it completes a satisfactory trial. Trainer Mike Reed reported that he would not continue training the mare.
JUPITERS DARLING – (Gary Hall Jnr) was checked behind a tiring runner in the back straight on the final occasion.

General

Driver Warren Robinson (WARBLING MAGGIE) was advised to give runners more room when shifting ground for having momentarily inconvenienced another runner racing towards the front straight on the first occasion.
