### **Stipendiary Stewards Report**

#### **Race 1: REGENCY FOODS 2YO FILLIES STAKES (1730 MBL)**

APACHE SUNRISE – (Ryan Warwick) which raced roughly after the start, was placed on its last chance in the draw. Checked racing towards the back straight on the first occasion.

BLAZING MUSTARD – (John Filardo) severely checked racing towards the back straight on the first occasion.

LADY CRANLEIGH – (Glenn Walker) failed to run on over the concluding stages.

DANMELBEN – (Rardi Barber) the near side sulky wheel was buckled racing towards the back straight on the first occasion when contacted by another runner.

#### **General**

Stewards inquired into the reason for BLAZING MUSTARD (John Filardo) breaking gait racing towards the back straight on the first occasion. It was established that DANMELBEN (Rardi Barber) shifted inwards when insufficiently clear of BLAZING MUSTARD making contact with that filly's fore leg. Rardi Barber (DANMELBEN) pleaded guilty to a charge of causing interference issued under the provisions of Rule 163(1)(a) and had his reinsperson's licence suspended for twenty eight days, to take effect following his driving engagements at Northam on Saturday 30<sup>th</sup> December 2006.

#### **Race 2: STAMPALIA CONTRACTORS CLAIMING STAKES (2130 MBL)**

THE LAST PADRON – (Craig Goldfinch) was checked behind a tiring runner racing out of the back straight on the final occasion.

JAGGED LINE – (Mark Reed) gave ground quickly from the 400m.

SOVEREIGN HEIR – (Shannon Suvaljko) failed to run on over the concluding stages.

COVENT GARDEN – (Morgan Woodley) which began badly, was excluded from the mobile barrier draw.

MON SHEKHAN – (Wesley Andrews) was checked after the start. Unable to obtain a clear run to the finish.

#### **Race 3: J & L FRUIT AND VEGETABLE DISTRIBUTORS STAKES (1730 MBL)**

PERFECT ORDER – (Colin Brown) was unable to obtain a clear run to the finish.

CASUAL FLING – (David Young) failed to run on over the concluding stages.

TROUBLESCENE – (Jarrad Humphries) when questioned on his driving tactics, in particular his reasons for remaining in the one wide line racing in the front straight to receive the bell rather than obtain a trailing position in the three wide line, driver explained that when taken wide over a similar distance previously, the mare had been obliged to race extremely wide on the track and had been unable to make ground. He further explained that the mare was best suited when being saved for a late sprint. At its previous start at Gloucester Park on 15<sup>th</sup> December over 2130m when taken wide in the middle stages with cover, the mare had not shown its usual pace over the concluding stages. He further advised that wherever possible TROUBLESCENE would be driven to take advantage of a late run.

FALCONOVA – (Nicolaas Van Der Snoek) out of position at release, driver reminded of his obligations. Broke gait when placed in restricted room racing towards the front straight on the final occasion.

**Race 4: FORCE EQUIPMENT & SERVICE HIRE STAKES (1730 MBL)**

CATCHMEMATE – (Andrew De Campo) which hung inwards and raced roughly racing from until racing out of the back straight on the final occasion until racing towards the front straight on the final occasion, was placed on its last chance to race truly.

WAKE NED DEVINE – (Kade Howson) completed the event with the near side lugging pole detached.

**Race 5: DANMAR HOMES CONDITIONED HANDICAP (2102 SS)**

COBARGO WIND – (Morgan Woodley) which stood flat-footed then commenced slowly, was placed on its last chance in the draw. Failed to run on over the concluding stages.

CANTAFEND – (Jason Vella) which broke shortly after the start, was placed on its last chance in the draw.

FORWARD POCKET – (Ryan Warwick) jumped sideways at the start and began badly losing considerable ground, will remain excluded from the Standing Start draw.

**Race 6: RED PEPPER CATERING 3YO STAKES (1730 MBL)**

STAR OF DALVEY – (Grant Williams) was held up obtaining a late run in restricted room.

LUNAR LYNX – (Morgan Woodley) which began badly, was excluded from the mobile barrier draw until such time as it has completed four satisfactory race or trial starts. Checked racing out of the front straight on the first occasion.

DILINGER WHITBY – (Ryan Warwick) which broke approaching the winning post on the first occasion losing considerable ground, was excluded from the mobile barrier draw.

THE STEWARDESS – (Andrew De Campo) checked racing out of the front straight on the first occasion.

AIKIDO WHITBY – (Chris Lewis) checked racing out of the front straight on the first occasion.

CLANCY THE ROCKET – (Callan Suvaljko) was severely checked at the start, checked racing out of the front straight on the first occasion.

HY ROYALE – (Mark Reed) was severely checked racing out of the front straight on the first occasion.

**Race 7: SELECT MORTGAGE CUP (2130 MBL)**

CLIONA LUCKY – (Ryan Warwick) failed to run on over the concluding stages.

MASSARUA – (Chris Lewis) failed to run on over the concluding stages.

**Race 8: INGLEWOOD FRESH IGA STAKES (2536 MBL)**

The Starter was obliged to call a false start at the first attempt when JUPITERS DARLING (Ryan Bell) broke in the score up checking a back line runner. JUPITERS DARLING was excluded from the mobile barrier draw.

REPARATION – (Gary Hall Jnr) shifted out under pressure in the run to the finish.

ONA REINBOW – (Shannon Suvaljko) was unable to obtain a clear run to the finish.

DARK AS SUEDE – (Warren Robinson) raced roughly racing out of the back straight on the final occasion.

SORRENTO TUESDAY – (Craig Saligari) had the offside sulky tyre flattened racing towards the front straight on the final occasion.

**Race 9: D & G HOIST & CRANES – NORTHERN SUBURBS CRANE HIRE HANDICAP (2503 SS)**

RENOUNCE – (Nigel Johns) galloped out.

BAYETE NKOSI – (Andrew De Campo) which began badly, was placed on its last chance in the draw. Unable to obtain a clear run to the finish and raced roughly over the concluding stages.

MOTU FLARE AND STYLE – (Kade Howson) which jumped sideways at the start, beginning badly, losing considerable ground, will remain excluded from the Standing Start draw.

J DS BEAU – (Morgan Woodley) was severely checked at the start. After being taken forward to gain the lead of the one wide line in the middle stages, failed to run on over the concluding stages. A post race veterinary examination revealed no abnormalities. An inquiry into the driving tactics adopted was opened and adjourned to enable Stewards to review previous performances of the gelding.

MR ACEMAN – (Callan Suvaljko) galloped out. Inconvenienced behind a tiring runner racing towards the front straight on the final occasion and gained an inside run over the concluding stages.

ALBERTS FANTASY – (Mark Reed) was checked at the start then shifted up the track under pressure in the run to the finish.

PAYNIN – (Chris Lewis) failed to run on over the concluding stages.
