# 2023 Fremantle Cup & WA Pacing Cup

#### **Terms & Conditions**

#### 1. NOMINATIONS

Nominations shall close at 4.00 pm (Western Australian Standard Time) on Friday 16<sup>th</sup> December 2022. All Nominations must be submitted on a Nomination Form and signed by either the Owner, Trainer or his Authorised Agent.

A non-refundable payment of \$220.00 (GST Inclusive) per horse must be received by 4.00 pm (Western Australian Standard Time) on Friday 16<sup>th</sup> December 2022 for the nomination to be valid.

#### 2. LATE NOMINATION FEE

Horses which are not nominated for the Fremantle Cup and WA Pacing Cup by 4.00 pm Friday 16<sup>th</sup> December 2022 can be made eligible by paying a Late Nomination Fee of \$5,500 (GST Inclusive) per race. Any late nomination payment must be made prior to the close of nominations for the Fremantle Cup (8am Monday 9<sup>th</sup> January 2023) or the WA Pacing Cup (8am Monday 23<sup>rd</sup> January 2023).

The Late Nomination Fee is non-refundable and does not guarantee a start in either the Fremantle Cup or WA Pacing Cup.

#### 3. WHERE TO LODGE NOMINATIONS

All nominations must be on the official form and must be received at the offices of RWWA by the due date. Forms can be sent to the above address.

#### 4. AGREEMENT

An Owner, Trainer or his Authorised Agent by nominating for the Fremantle Cup & WA Pacing Cup thereby agrees to abide by RWWA's Rules of Harness Racing.

#### 5. HORSES REMAIN ACCEPTORS UNLESS WITHDRAWN

A horse nominated for the Fremantle Cup and WA Pacing Cup is automatically an acceptor unless withdrawn prior to acceptance time for the Fremantle Cup and WA Pacing Cup.

#### 6. RANKING SYSTEM

The rankings will be at the discretion of the RWWA Field Selection Panel. In framing the rankings, consideration will be given but not limited to the following:

- Stakemoney earned in last five starts
- Current form (last 5 race starts)
- Extended current form (last 10 race starts)
- Lifetime performance

When considering form, the Field Selection Panel will be mindful of the class of races competed in, the quality of the opposition and the circumstances of each race (barrier draw, interference received etc.) In framing the rankings, the Field Selection Panel has absolute discretion to apply whatever weighting they consider appropriate to each of the above.
